**SUPPLEMENTAL ORDER TO EXTEND CLAIMS DEADLINE
AND PROVIDE NOTICE OF EXTENSION**

On December 16, 2020, the parties filed a Joint Statement to Extend the Claims Deadline, setting forth the parties' agreement, in light of the COVID-19 pandemic and its impact on businesses, to extend the deadline for Multi-State Class Members to submit their claim forms from December 15, 2020 to March 31, 2021. (ECF 116). The Motion for Final Approval of Class Settlement (ECF Nos. 104-106) and Motion for Attorneys' Fees, Reimbursement of Expenses, and for Service Award (ECF No. 103), to which the Joint Statement relates, was heard on December 17, 2020 at 11:00 a.m. Eastern via remote technology. Upon consideration of the parties' agreement, and for the reasons stated during the final approval hearing, **IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:**

1. The deadline to submit claims is hereby extended from December 15, 2020 to March 31, 2021.
2. The Settlement Administrator is directed to provide notice of this extension to Settlement Class Members in the following manner:
 - a. Postcard and email notice sent by or before January 11, 2021 to those previously deliverable physical and email addresses of Multi-State Settlement Class Members who have not yet submitted claims;

b. Publication of the new claims deadline on the Settlement website

www.pressfittingssettlement.com, by or before January 11, 2021;
