Please read the entire Rebate Claim Form carefully before you begin to fill it out. This form is to claim rebates for purchases between **December 18, 2020** and **December 31, 2021**. The Rebate Claims Period begins on **January 1, 2022**. The deadline to submit your Rebate Claim Form is **March 1, 2022**. Please visit the website www.PressFittingsSettlement.com before submission to confirm all dates and deadlines. **You MUST submit your claim before the submission deadline that appears on the website to be eligible for a rebate payment.**

Instructions

To participate in the Rebate Program, visit **www.CopperPressFittingsRebate.com** and use it to: (1) register with the Rebate Program; (2) activate the Rebate Program within your account; and (3) upload this form and supporting documentation. You can also mail this form and supporting documentation to **Copper Press Fittings Rebate Program, 2299 Perimeter Park Dr., Unit 150, Atlanta, GA 30341**, however online submission is preferred and your claim will be processed faster.

*If you submitted a Claim Form for a Cash Settlement Payment, you were provided with a Unique ID number from the Settlement Administrator, which allows you to skip the qualification process now. If you did not previously submit a Claim Form, please write "N/A" on the Unique ID line above, and upload with this form a Proof of Purchase for at least one (1) Viega ProPress® copper press fitting between the period of **January 29, 2015**, and **September 18, 2020**, to confirm your eligibility for this Rebate Program. For avoidance of doubt, if you previously did this to qualify for the Cash Settlement Payment and have a Unique ID, you do not need to again confirm eligibility.

Only purchases of Viega ProPress® fittings are eligible for a rebate—**Purchases of Viega ProPress®-related tools and Viega ProPress® valves as well as other Viega branded products are excluded from and not eligible for the Rebate Program.** Taxes, surcharges and fees are excluded from and not eligible for the Rebate Program. You must include the "requested rebate information" in all fields with an asterisk (*) or your Rebate Claim Form is invalid and will not be paid. If the Viega ProPress® fitting part number is not included on the invoice(s) submitted for rebate, you will need to clearly specify in the "Item/Product No. or Description" column the product description (fitting type[s] and size[s]) for that invoice. List each different product type on a different line, even if on the same invoice. See examples below.

You must include all receipts with your Rebate Claim Form. Listed purchases without Proof of Purchase documentation will be invalid and not paid.
